Overview

The purpose of this document is to give greater detail about the effect that the Phased reopening will have on specific ministries.

This information is dependent upon the spread of the virus and can change depending on new information.

Sunday On-site Worship Service Reopening

June 7 and June 14

- Worship services at 9:00 and 10:30 with staff present
- Online Streaming 9:00 and 10:30

June 21 and Moving Forward

- Worship on-site for congregation (Older individuals with health condition encouraged to continue to watch online until July)
- Service times are 9:00 and 10:30
- Online Campus launch. Service times are 9:00 and 10:30 and will be live

Safety Measures Being Taken

- 6 feet social distancing will be in effect
- One entrance will be in effect. This entrance will be at the front (east side) of the building
- One exit will be allowed through the front of the building
- Volunteers will be present to help with directions
- Seating will be restricted to every other row and there must be at least 4 seats between you and another person. Families living in the same house may sit next to each other
- The worship auditorium will be sanitized after each service by a contracted third party
- The lobby will be wiped down continually
- We are asking for no hand shaking or hugging
- Facemasks are encouraged and lobby staff will be wearing facemasks
- No food or drink will be available in accordance with the instructions from the State of Indiana
- Valet service is discontinued
- Kids ministry is closed until schools reopen in accordance with instructions from the State of Indiana
- No onsite meetings during a Sunday will take place until further notice. This includes but is not limited to MP Groups, Sunday School, classes, Middle School, and High School
- Baptisms will continue with additional precautions

Office Staff

- The church staff will return to the office on June 15
- New church office hours will be M-Th 8:30 4:30. The office will be closed on Fridays
- Remote work remains a possibility for specific situations

MP Learning Place

- Daycare will continue to follow state guidelines for social distancing until instructed otherwise
- Days of operation will continue to be Monday Friday
- Installed disinfecting blue lights into the HVAC system to improve air quality
- Staff encouraged to wear facial coverings
- Food staff required to wear coverings
- Cleaning performed by outside company 5 days a week

Cleaning Operations

- Installed a UV light disinfecting system to the HVAC system in the children's wing to improve air quality
- We have contracted with an outside cleaning company which will follow CDC guidelines for cleaning
- The daycare will be cleaned daily by the contracted company and the teachers will also be following strict cleaning guidelines

Kid's Ministry

- Maintain online format until further notice
- The state has asked for kid's ministries to remain closed until school is back in session. This will be continually reviewed
- No camps or trips until further notice

Middle School

- No onsite meetings until further notice
- Maintain online format until further notice
- No camps or trip until further notice

High School

- No onsite meetings until further notice
- Maintain online format until further notice
- No camps or trip until further notice

MP Groups, Sunday School and Classes

- No onsite meetings for MP groups, Sunday School and classes until further notice
- Some specialty groups make resume facility use June 1 or on case by case basis

External Events

- External events can take place within social distance limits on a case by case evaluation
- Cleaning costs will be added to each contract for rental of the facility
